

#### Housing Helpline has seen steady increase



# CoC Lead Agency



#### **HUD** requirements

- Through <u>HUD Program interim rule</u>, Continuum of Care (CoC) are established to "increase the efficiency and effectiveness of coordinated, community-based systems that provide housing and services to the homeless"
- Major duties include
  - Operate the CoC
  - Designate an HMIS for the CoC
  - Plan for the CoC



# Collaborative Applicant



### Applying for HUD funding - CoC

 HUD releases an annual CoC NOFO to provide funding for Supportive Services, Permanent Housing, Transitional Housing, HMIS, (in addition to a Planning grant)

#### CoC duties

- Submit a community application as the "Collaborative Applicant"
- Provide public notification of funding opportunity
- Provide technical assistance and support to project applicants
- Oversee a competitive application process using scoring criteria that is informed by local priorities



## Applying for HUD funding - ESG

- NC DHHS releases an annual Emergency Solutions Grant (ESG)
  RFA to provide funding for:
  - Emergency Response Services (Emergency Shelter and Street Outreach)
  - Housing Stability (Rapid Re-housing, HMIS, and Targeted Prevention)


#### CoC duties

#### What is HMIS?

- •HUD requires CoC's to collect and required defined data elements regarding persons served through homeless service systems and programs
  - •These elements are used to measure program and system performance
  - •Orange County (as well as Durham County and Balance of State) uses NCCEH to administer HMIS as the HMIS Lead Agency

#### CoC duties

- •Manage data for CoC programs and ensure timely submission of required reports
- •Monitor user account to ensure compliance, including annual trainings
- Serve on the NCCEH Executive Team and Advisory Board



# OCPEH Teams: The right mix of funds and services

#### There Are Different Outcomes Based On Household Need



#### **OCPEH** Team

- •Housing Helpline Provides a standardized single point of access to programs and services from information to assessment to referral
  - •Housing Helpline answered calls / emails Monday Friday; 10am 4pm
  - •Accepts walk-in service at Southern Human Service Center Tuesday and Thursday 8:30am 4pm
- •Homelessness Prevention Provides housing stabilization and when needed housing search, referrals and short-term case management
  - •Accepts referrals from Housing Helpline, Eviction Diversion and Prevention program, and OC Housing Authority



#### **OCPEH** Team

- •Rapid Re-housing Provides housing search, referrals, and short-term case management to quickly achieve stabilization
  - Accepts referrals through HOME committee
- •Street Outreach Harm Reduction and Deflection Provides people experiencing unsheltered homelessness with relationship-based connection to housing and services
  - •Accepts referrals from Housing Helpline, community stakeholders including business owners, law enforcement and self-referral



#### **OCPEH** Team

- •Housing Access Coordinator Provides engagement/retention with property owners and community stakeholders to increase availability of affordable housing; provides tailored housing search support to people with multiple barriers to housing; builds community capacity on how to conduct a housing search
  - Accepts referrals from OCPEH programs, OC Housing Authority, and community stakeholders
- •COVID isolation lodging Provides isolation lodging for people experiencing homelessness while they require isolation due to COVID 19
  - •Accepts referrals from healthcare and homeless service providers
