CoC Application: Project Priority Listing

Avoiding conflict of interest

- Per [OCPEH Governance Charter](#) & [24 CFR 578.95\(b\)](#)
 - Leadership Team members cannot participate in or influence discussions or resulting decisions concerning funding
 - Signed Conflict of Interest forms updated annually
 - Employee, donor, volunteer, member, board member, trustee, or any other affiliation
 - Recuse from discussions or decisions that violate conflict of interest
 - Potential grantees also cannot participate in discussions or decisions for CoC or ESG funding
 - Anyone to note in minutes recusing themselves from discussion and decisions?

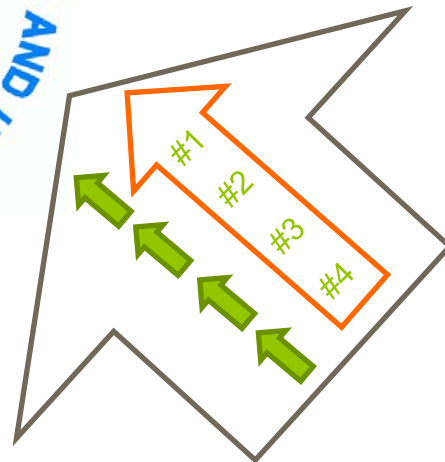

2019 CoC Application Process

- July 22 Project Review Committee Orientation
- July 22 New and Renewal CoC Project Info meeting
- Aug. 21 Project applications & materials due
- Aug. 23 -Sept. 2 Project Review Committee scoring
- Sept. 6 9 Project Review Committee review & ranking
- Sept. 10 Leadership Team review & ranking meeting
- Sept. 20 Community application review begins
- Sept. 23 Project applications revisions complete
- Sept. 24 Staff posts CoC application on OCPEH website for community review
- Sept. 27 Staff submits completed application to HUD

\$784,708 in available funding

Description	Amount	Eligible Applicants
Annual Renewal Demand (ARD): Amount to fund all renewal CoC projects for FY2017	\$680,285	Nonprofits, Governments, Public housing authorities
Domestic Violence (DV) Bonus: New project funding dedicated to survivors of domestic violence, dating violence, sexual assault or stalking	\$50,000	
Bonus: New project funding awarded to communities that score highest on CoC application	\$ 34,014	
CoC Planning: Coordinating activities like strategic planning, governance, and performance improvement	\$ 20,409	Collaborative Applicant (Orange County)

Agencies submitted 5 project applications

- Some projects are renewal/expansions, some are new projects
 - 3 renewal projects
 - 2 new projects
- We have different project types
 - 2 Permanent Supportive Housing (PSH) projects
 - 2 Rapid Re-Housing (RRH) project
 - 1 Supportive Services Only (SSO) Coordinated Entry project

The big picture of 2019 CoC funding

• Renewal projects	\$680,285
• DV Bonus	\$50,000
• Bonus	\$34,014
• SUBTOTAL	\$764,299



• CoC planning	\$20,409
• Not ranked	
• GRAND TOTAL	\$784,708

There are 2 considerations with ranking: order of Project + Tiers

- Order of projects = ranked 1 through 5
- Tiers are an added level of complexity

Tier 1	More secure	\$642,476
Tier 2	More risky – may not be funded	\$37,809
Total		\$680,285

- *HUD recommends ranking DV Bonus projects where they fall in local competition, based on local criteria, etc.*

Projects submitted more funding request than is available

- Total ranked funding requested \$860,285
- Total ranked funding available \$680,285
- Tier 1, 94% of renewals
 - \$642,476
- Tier 2, 6% of ARD
 - \$37,809

CoC Bonus and DV Bonuses Total:

- *\$84,014*

 - Numbers adding up
 - Point maximization

3. Community application

- Important to maximize points here to maximize funding
- Staff to draft next week, send to Community Application Committee for review
- Entire CoC application will be posted on OCPEH website the week of September 20 for community review and input.

CoC Collaborative Applicant (OCPEH) eligible to apply for CoC Planning grant

Grant Year	Amount	Purpose
2014	\$6,750	OC Connect database <ul style="list-style-type: none"> • Resource database • Coordinated entry
2015	\$17,000	Training
2016	\$18,249	Project evaluation, Project monitoring, and HUD compliance activities
2017	\$19,161	Develop project evaluation and monitoring process, evaluate coordinated entry effectiveness
2018	\$19,934	Coordinated Entry support & Training and Restorative Justice
2019	\$20,409	System-Wide Trainings and Technical Assistance

Not a ranked project – these are funds on top of project funds
