# The HOME list is the longest it's ever been; 4 people housed at the last meeting

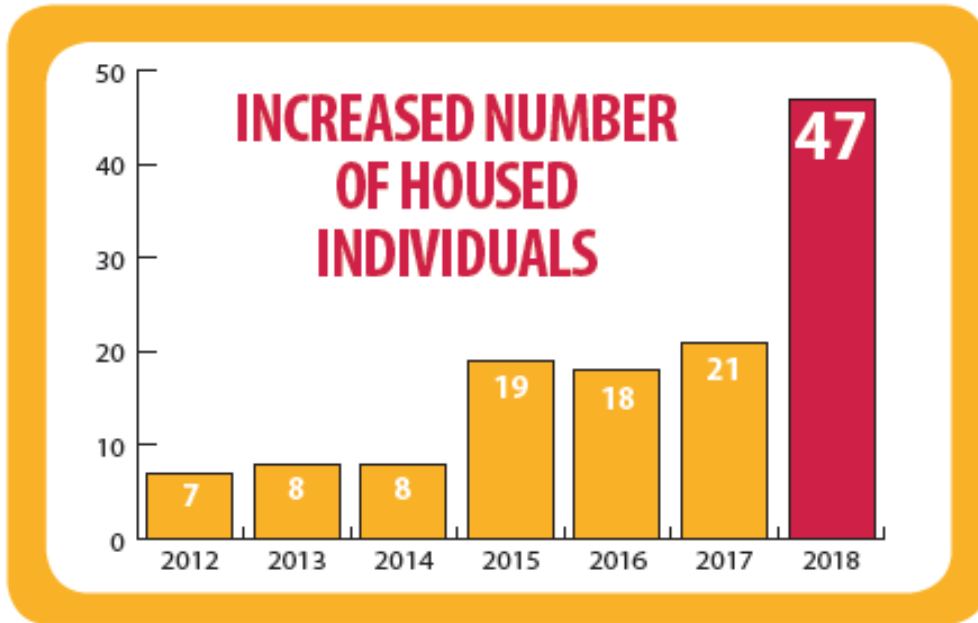

# Gap of the Month: Rapid Re-Housing

# Starting this month, we will take a closer look at each of the remaining system gaps

- In 2017, stakeholders identified eight homeless service system gaps as part of the 2016-2017 system mapping process
- Latest [update to Gaps Analysis from April 2018](#)
  - 1 gap filled
  - 6 gaps had some activity underway but not fully filled
  - 1 gap with no movement yet
- We can end homelessness in Orange County, to do this we must fill the remaining gaps
  - Focus of Leadership Team work for 2019 and beyond

# #1 Prioritized Gap: Rapid Re-Housing

- Rapid Re-Housing is short-term services and financial assistance for people with mid-range of service need
- Low barrier – serve all people, don't require sobriety, etc.
- Highly flexible in all regards, financial and services
- 3 core components
  - Housing identification
  - Rent and move-in assistance
  - Case management
- Why Rapid Re-Housing instead of Transitional Housing?
  - Less expensive
  - Shortens length of time homeless
  - Serves more higher need folks
  - Research shows it works

# A fully funded, best practice Rapid Re-Housing program would fill the gap

- 2 FTE case manager positions \$100,000
- Financial assistance to serve 60 households per year \$472,000
  - 30 low service need (\$3,300/household)
  - 20 mid service need (\$8,750/household)
  - 10 high service need (\$19,800/household)
- One-time costs (equipment, computer) \$ 6,000
  
- **Total cost 1 year \$ 578,000**
- **Total cost 5 years \$2,866,000**



# There are a variety of funding sources for Rapid Re-Housing

- Primarily – ESG, and this has rapidly decreased in recent years
  - 2018                 \$24,083
  - 2017                 \$59,636
  - 2016                 \$58,927
  - 2015                 \$70,859
  - 2014                 \$160,582
  - 2013                 \$105,564
  - 2012                 \$194,914
- Other funding sources
  - CoC
  - Existing partners: CSBG, HOME, TH Assistance Grants for Victims of SA/DV
  - In other states: TANF, SSBG, Title IV-E
  - County/Towns and Foundations - case management staffing, flexible funding  
Foundations - case management staff, flexible fund
  - Fundraising event





# If we filled the gap, many more people would exit to housing quickly

- Increase in the number of people housed from HOME list
- Decrease in number of months on the list
- Decrease in length of time homeless
- Free up beds at shelters for people entering system
- Current context: 95 people on HOME list
  - 64 have a VI-SPDAT score range of 4-9 (mid range of service need)
  - 20 additional people have scores of 10-11, unlikely to receive PSH
  - 11 have scores 12 or higher (high level of service need)
- Demonstrated success, Sept. 2017 – January 2018
  - 12 people housed in 4 months (1 case manager, full funding)
  - 5 people housed in past 12 months (no case management, limited funding)
