


Avoiding conflict of interest

- Per <u>OCPEH Governance Charter & 24 CFR 578.95(b)</u>
 - Leadership Team members cannot participate in or influence discussions or resulting decisions concerning funding
 - Signed Conflict of Interest forms updated annually
 - Employee, donor, volunteer, member, board member, trustee, or any other affiliation
 - Recuse from discussions or decisions that violate conflict of interest
 - Potential grantees also cannot participate in discussions or decisions for CoC or ESG funding
 - Anyone to note in minutes recusing themselves from discussion and decisions?

Project Review Committee scored and ranked project applications

- 1. Scoring a few issues for Leadership Team review
 - Scoring particulars
 - Unmet thresholds
- 2. Ranking
 - Project Review Committee crafted a proposed ranked list of projects for Leadership Team review



Project Review Committee discussed several scoring particulars

- Coordinator did not score
- Some overlaps between Threshold and Scoring
 - Cost per permanent housing exit
 - Documented, secured minimum match
 - Housing First and/or Low Barrier Implementation
 - Coordinated Entry participation
- Made some adjustments to rubrics
 - Added 5 point threshold for 3 questions on Serving High Need Clients
- Awarded max points for income questions re: leavers when there were no leavers

Project Review Committee discussed several scoring particulars

- For some questions all projects scored max points, will have better data next year – left on this year to communicate CoC priorities
 - 95% referrals from coordinated entry
 - 180 or fewer days between program start and move in
 - Project operating in accordance with CoC standards
- Added questions from PSH Best Practices form
 - PSH caseload meets SAMHSA recommendation of 10-20 clients per case manager – 10 points

Unmet Threshold Measures

- Per the HUD Rating & Ranking Tool, "CoCs will need to adopt policies to decide whether to rate projects that do not meet all HUD Threshold Requirements and all CoC Threshold Requirements."
- Of 7 submitted projects, 4 have unmet thresholds
 - 3 of 4 renewal/expansion projects
 - 1 of 3 new projects
 - Coordinated Entry project largely unrated



Unmet Threshold Measures

- Community Link Orange PSH Renewal
 - Housing First and/or Low Barrier Implementation
 - Applicant is active CoC participant
 - Data quality at or above 90%
- IFC PSH 2018 Expan. Reallocation Renewal
 - Project has reasonable costs per permanent housing exit, as defined locally
 - Data quality at or above 90%
 - Bed/unit utilization at or above 90%
- IFC Orange Co. Housing Support Renewal
 - Data quality at or above 90%
- Compass Center RRH for DV Survivors and Their Families New
 - Applicant is active CoC participant

Options for Unmet Thresholds

- Communicate discrepancy to agency, issue a "waiver" for 2018 CoC competition
 - Falls into line with ongoing project performance launched this year
 - Quarterly data reviews with all CoC and ESG grants
- Eliminate some Threshold Measures, required to have top 5, additional 6 are optional

There are 2 considerations with ranking: order of project + Tiers

- Order of projects = ranked 1 through 7
- Tiers are an added level of complexity

Tier 1	More secure	\$624,609
Tier 2	More risky – may not be funded	\$39 <i>,</i> 869
Total		\$664 <i>,</i> 478

- DV Bonus project could be funded by DV Bonus (if selected nationally), Tier 1, or Tier 2
 - HUD recommends ranking DV Bonus projects where they fall in local competition, based on local criteria, etc.



Projects submitted more funding request than is available

- Total ranked funding requested
- Total ranked funding available
- Tier 1, 94% of renewals
 - \$624,609
- Tier 2, 6% of renewals + Bonus + DV Bonus
 - \$ 39,869

 - Consistency & clarity
 - Numbers adding up
 - Point maximization
- 2. Project priority listing done
- 3. Community application
 - Important to maximize points here to maximize funding
 - Staff to draft next week, send to Community Application Committee for review
 - Entire CoC application will be posted on OCPEH website Sept. 13 for community review
