Presentation on Master Lease Proposal

A group of business people, advocates, and people experiencing homelessness have crafted a proposal to house many extremely low income households in Orange County using Master Leasing, aka "subletting with a social mission."

- Same concept except there is an entity that is originating the leases with multiple landlords throughout town. Subletting these apartments out to individuals who are at risk or currently experiencing homelessness, screening them, and renting them with a subsidy. Handle as much of the screening side as possible to get over barriers to housing. From a landlords perspective, they get units rented (full amount) for a designated amount of time with assurance that they will get paid it simplifies their lives and allows the entity to lower the barriers as much as possible with little risk to landlords. Case management built in as well.
- The ideal agency to host this would be an entity with a track record around affordable rentals
- The group wants to tap into existing funding streams and avoid competing funds that are going to Permanent Supportive Housing and other homeless programs.
- Potential questions to answer:
 - utilities, gas and electricity
 - o Can the Risk mitigation fund be incorporated into this?
 - O What is the cost for administrative fees?
 - O When will preliminary conversations with landlords begin?
 - Letters of consistency? Those conducting would like very specific feedback.

Point-in-Time Count Updates

OCPEH coordinated the annual Point-in-Time (PIT) count on January 31, 2018 – the annual count of people experiencing homelessness on one night. The Coordinator will review preliminary numbers and next steps.

Takes quite a long time to analyze the data. Currently, the partnership sees 25 surveys from
the street count and 22 surveys from the service count, but will continue to de-duplicate,
including people that were going to the cold weather shelter. The final numbers are due to
HUD May 1st. The count went well overall with the weather being normal, which shows a more
accurate representation. There was great participation from agencies during the service count

Plan to End Homelessness - Progress Report & Proposal for 2018 Updates

The Coordinator reviewed progress on action items in 2017-2018 Orange County Plan to End Homelessness and discuss next steps. The Coordinator will also present options for updating the Plan this Spring (current plan ends June 2018) including holding a series of listening sessions for different stakeholder groups.
