Meeting Minutes & Updates

A motion was made to pass <u>Leadership Team Minutes from the meeting on 12/21/20</u> [Foushee, Bedford]. All in favor, none opposed.

OCPEH Updates

- Point-in-Time Count will be Wednesday, January 27 the Street Outreach, Harm Reduction, and Deflection (SOHRAD) team will take the lead on the street count, working with homeless service providers to participate in the service count
- FY2020 Continuum of Care grants will be renewal only, no grant competition; HUD says will also have a chance to apply for new funding waiting to hear more from HUD on all of this
- FY2021 Continuum of Care grant registration opened by HUD
 - OCPEH will register as collaborative applicant, not as Unified Funding Agency the Leadership Team will review UFA application possibilities again for the FY2022 CoC registration
- A motion was made to approve the current <u>OCPEH Governance Charter</u> with no changes from the previous version, the Manager will post a version with the revised amended date [Bedford, Foushee]. All in favor, none opposed.

ESG-CV Round 2 Funding Decision

Orange County can apply for \$463,824 for in the second round of the Emergency Solutions Grant CARES Act funding (ESG-CV Round 2). Two agencies, the Inter-Faith Council for Social Service (IFC) and Orange County (OC), applied for four projects totaling \$535,399. The Orange County Project Review Committee recommends funding IFC Cold Weather Cots, IFC COVID Team Lead, and OC Housing Stability Case Manager and Coordinated Entry Prevention staff at the funding request level, and funding OC Rapid Re-housing financial assistance at \$129,675, below the \$201,250 requested.

A motion was made to recommend funding for 12 months of the IFC COVID Lead position, full funding for IFC Cold Weather Cots, \$173,736 for Orange County Rapid Re-housing financial assistance, and full funding for the Orange County Housing Stability and Coordinated Entry staff [Fenhagen, Foushee]. All in favor, none opposed, Jenks and Sutton recused.

Leadership Team Membership

The Leadership Team decided to pause board development activities during racial equity training ongoing until May 2021. A motion was made to extend terms of all members currently on the board
